INNOVATION

We strengthen organized consumer voices wherever important decisions about the health system are made – in communities, courtrooms, statehouses and Congress.

Building a strong and informed consumer voice

Our health care system is badly in need of repair, but reform should not be shaped exclusively by powerful interests. Community Catalyst supports state and local advocacy groups so an organized consumer voice is heard in health care debates.

The *State Consumer Health Advocacy Program* provides a broad range of training, development and coalition-building support to consumer advocates, tailored to the unique circumstances in each state. We offer practical tools like an online system for advocates to design coverage expansions step-by-step, building on their states' existing public and private health insurance options.

As a region, the South presents specific challenges due to poverty, political environments and disparities in health care access and outcomes. People with lower incomes and members of racial, ethnic and cultural minorities are most at risk under our current health system. We make sure they are engaged in shaping reform. Funded by the Public Welfare Foundation, our *Southern Health Partners* program uses a regional framework to help consumer advocates address issues such as children's health care, tobacco control, Medicaid coverage, and access to care.

Community Catalyst ensures that federal reform efforts are informed by the experiences and accomplishments of state health advocates. We promote federal policies that protect consumers and support successful state initiatives, and we help consumer advocates influence national health policy.

Expanding health care access

Tens of millions of Americans do not have health insurance, and millions more have coverage that is inadequate. Community Catalyst helps create and nurture some of the country's most influential health advocacy groups to tackle complex issues essential to meaningful reform – funding, access to care, benefit design, and affordability.

Consumer Voices for Coverage, a joint initiative with the Robert Wood Johnson Foundation, recognizes consumer advocates' crucial role in expanding innovative and comprehensive health care. As the National Program Office, we promote cross-state coordination so advocates can share strategies and policy solutions while identifying emerging opportunities for action.

The *New England Alliance for Children's Health* builds coalitions of hospitals, advocates, healthcare providers, business leaders, interfaith organizations, and consumers to ensure that all children in the region have access to the highest quality healthcare.

Improving quality of care

The health care system is confusing for everyone, but especially for seniors, people with disabilities and those with complex health care needs. Without appropriate care tailored to their individual needs, they become sicker and end up in hospitals or nursing homes.

The *Integrated Care Advocacy Project* works to change the way care is delivered to people with special health needs. We promote coordinated care systems that improve quality and bring greater value to public programs. Fostering partnerships between mission-driven health plans and consumer advocates, we advance small-scale innovations to bring about big changes that reach throughout the health system.

Reducing medical debt and protecting hospital safety-net care

Medical debt is the #1 cause of personal bankruptcy in the United States, and it is not just a problem of the poor and uninsured. Millions of Americans have health insurance that fails to cover them adequately.

Community Catalyst helps communities establish enforceable standards that ensure nonprofit hospitals and health plans provide charity care and programs to address unmet health care needs. The *Hospital Accountability Project* provides grants to coalitions working to increase safety-net care and eliminate unfair billing practices so that people do not fall into a cycle of medical debt.



When nonprofit health care organizations convert to for-profit status, Community Catalyst focuses on maintaining vital community health services while preserving charitable assets that have been built by and for the public. We work with state and local health foundations to engage communities in health system improvement.

Ensuring access to public benefits for low-income families

Community Catalyst developed RealBenefits® to combat the lack of information, complex procedures, and confusing rules that keep millions of people from enrolling in public programs for which they qualify. RealBenefits advocates policy change to streamline benefits enrollment nationwide.

Its web-based service enables organizations to easily connect people with health insurance, food stamps and other services. The MacArthur Foundation has honored RealBenefits for its innovative combination of technology and community outreach.

Imagine a health care system where the benefits of pharmaceutical innovations are available to everyone, without excessive costs, deceptive marketing, or conflicts of interest that compromise patient care.

Making pharmaceuticals affordable and safe

The *Prescription Project* works to eliminate conflicts of interest that result from the gifts, dinners and samples that drug companies offer providers. The project, created with Pew Charitable Trusts, leads a national effort to eliminate drug company abuses through action by Congress, the FDA, state legislatures and academic medical centers.

We promote prescribing based on scientific evidence, not marketing. Community Catalyst also helps community-based organizations educate consumers about the safety, value and effectiveness of generic drugs.

Prescription Access Litigation built a coalition of more than 130 consumer advocacy organizations, labor unions, and nonprofit health plans challenging anti-competitive practices, price manipulation and deceptive marketing in the pharmaceutical industry.

The coalition has been involved in more than 30 class action lawsuits and resulting settlements have changed the way drug companies conduct business and reimbursed more than \$600 million to consumers and health plans that were illegally overcharged.
